

Official Address by the Chairman of the board of JSC "Uzkimyosanoat" on Combating Corruption

Dear colleagues, members of the public, and partners,

Today, the fight against corruption has become one of the key priorities of our country's state policy. Under the leadership of the President of the Republic of Uzbekistan, Shavkat Mirziyoyev, bold and systematic reforms are being steadily implemented in this area. Recognizing corruption as the greatest obstacle to reforms, the head of state is introducing large-scale, people-oriented, and transparent mechanisms to counteract this scourge.

Within the framework of this policy, JSC "Uzkimyosanoat" is also implementing effective anti-corruption systems across all its enterprises and divisions, adhering to the principles of prevention, transparency, and accountability.

Our core activity is the production of mineral fertilizers and their efficient distribution in both domestic and international markets. Ensuring a fair, transparent, and corruption-free environment is not only the foundation of our internal system's stability but also the key to building trust with international partners and investors.

JSC "Uzkimyosanoat" operates not only within the national market but also on the international stage. Therefore, establishing transparent and trustworthy relations with foreign investors, protecting their legal guarantees, and creating a transparent business environment are among our top priorities.

The attraction of over \$120 billion in investments over the past seven years and the doubling of our national economy are results of a policy based on transparency and the rule of law.

At the meeting of the National Anti-Corruption Council held on March 5, 2025, President Shavkat Mirziyoyev outlined 55 specific initiatives, including:

- Strengthening compliance control,
- Introducing electronic platforms in public procurement,
- Preventing everyday (petty) corruption,
- Declaring the income of public servants,
- Ensuring active participation of civil society.

These priorities now form the core focus of our operations.

This year, JSC "Uzkimyosanoat" is working on launching a modern Situational Center aimed at ensuring transparency, preventing corruption risks, and improving the efficiency of public fund utilization.

The Situational Center offers a range of advantages and capabilities:

1. Continuous monitoring of public procurement
 - o Open analysis of procurement plans, announcements, tender results, and contracts;
 - o Transparency and equality ensured at all stages.
2. Data-driven decision-making control
 - o Automated analysis of procurement statistics and dynamics;
 - o Monitoring of pricing trends, demand, and supply.
3. Reducing corruption risks
 - o Automated identification of corruption risk indicators for each procurement;
 - o Timely detection of suspicious deals and collusive tenders.
4. Real-time monitoring of financial flows
 - o Real-time control over payments to tender winners;

o Early detection of potential conflicts of interest.

Dear team members and partners,

Corruption is not only a violation of the law but also an obstacle to development and a betrayal of social justice. Unless we – leaders, specialists, and workers – stand united in this fight, we will not achieve meaningful results.

JSC "Uzkimyosanoat" remains committed to fulfilling its anti-corruption obligations with integrity. The principles of honesty, transparency, and accountability will continue to guide every aspect of our work. To preserve and build upon our current achievements, I call on everyone to engage in mutual cooperation, assume responsibility, and work with integrity.
