On the basis of a contract on the assessment of the corporate governance system with "Uzkimyosanoat" JSC from 20.04.2022 #237351, an independent assessment of the system of corporate governance of "Uzkimyosanoat" JSC was carried out.

An independent evaluation of the corporate governance system was conducted to implement the recommendations of the Corporate Governance Code.

At the same time, an independent evaluation of the corporate governance system "Uzkimyosanoat" JSC was made on the basis of a questionnaire, approved by the State Committee of the Republic of Uzbekistan for the promotion of privatized enterprises and competition development and the Scientific and Educational Center for Corporate Governance and the information provided by the company, as well as information posted on the Unified Corporate Information Portal ([www.openinfo.uz](http://www.openinfo.uz)).

The management of "Uzkimyosanoat" JSC is responsible for the preparation and reliability of the contents of the information provided by the company.

The valuation was carried out in accordance with the current legislation of the Republic of Uzbekistan and in accordance with the recommendations of the Corporate Governance Code Approved by the Minutes of the meeting of the Commission for Enhancement of Efficiency of the Joint-Stock Companies' Activity and Improvement of the System of Corporate Governance, dated December 31, 2015 No 9, as well as internal corporate documents of "Uzkimyosanoat" JSC.

Based on the results of the implemented procedures, sufficient data were obtained for the formation and expression of independent opinion.

## CONCLUSION

According to the results of the independent evaluation, the system of corporate management of "Uzkimyosanoat" JSC is recognized as **"high"**, as in the calculation the issuer scored **900** points, which is **75%** of the maximum possible result.
